Take Route 128 South to Route 3 South (headed towards the Cape.) Follow Rte 3 South to Exit 12 (sign will read Marshfield/Pembroke-Rte 139.) Bear right at the end of the ramp (this will put you on Rte 139 East). Follow Rte 139 East to your third set of lights. Take a left at this set of lights onto Furnace St. Follow Furnace St. to your first intersection and take a left onto Forest St. The high school is on your left.

**FROM  
SOUTH**

Take Rte 3 North-Exit 12 (sign will read Marshfield/Pembroke Rte 139). Bear left at the end of the ramp (this will put you on Rte 139 East). Go to your second set of lights and take a left onto Forest St. Follow to your first intersection-take a left onto Forest St. The high school is on your left.

Routes

Routes 3A and 139 join in Marshfield center, and then separate. When they split, you Rte. 3A should continue north on 3A, bearing right just after the Citgo station. Do not stay on Rte 139. At the first light turn left onto Furnace St. Follow to first intersection to Forest St. The high school is on your left. After you cross the Scituate/Marshfield town line, watch for VFW Post 8345 on your right. Go another quarter mile to the light at Furnace St. and turn right. Go about four-tenths of a mile South and turn right onto Forest St. The high school is on your left. After about two-tenths of a mile on Forest St. you should take a left at the one-way sign into the semi-circular driveway in front of the high school. (You will have just passed a one-way sign coming out of this semi-circular driveway in front of the school.) You also will have passed a parking lot with a hockey rink, a soccer field and playground. Under the one-way sign going in will be a white sign with red letters. Park in front of school. Use the right wing entrance near the flagpole marked GUIDANCE.

Take Exit 6, take a slight right at the stop sign traveling up Rte.132 enter the rotary and take the 3<sup>rd</sup> exit IYANNOUGH RD/MA-28. The VFW Post 2578 will be on your right

**From points West**

Find your most direct route to 495 South. Follow until it becomes Rte.25. Follow the signs for Cape Cod and follow Rte.25 all the way over the Bourne Bridge to the rotary on the other side of the Cape Cod Canal. Follow the rotary ¾ of the way around and turn right. Follow 6A parallel to the Canal for about 6 miles and look for signs to the Mid-Cape Highway Rte.6 to Hyannis. Follow Rte.6 to Exit 6.
